Syllabus of LL.M. Entrance Test, 2022: -

The syllabus is divided in two parts. The total marks of LL.M. Entrance Test are 100.

Part-I (Objective) of syllabus consists of Multiple Choice Questions (MCQ). Total marks: 60 (each question carry one mark.).

Part –II (Subjective) of the syllabus is based on Analytical/ Subjective and descriptive Questions. Each Question consists of 10 marks. The question to be answered in around 1000 words each. Total marks: 40
