Important Instructions for the provisionally selected candidates:

1. Original documents required for counseling along with one set of self- attested Xerox copy of all the below mentioned documents:

- A. Mark Sheet of Class 10th
- B. Mark Sheet of Class 12th or equivalent.
- C. Transfer Certificate/Migration Certificate
- Character Certificate
- E. SLC/CLC (School/College Leaving Certificate)
- F. Anti-Ragging Declaration & Attendance Undertaking (Duly Affidavited and Notarized)
- G. Caste Certificate (If Applicable)
- H. Domicile (For those who are claiming the benefit of Reservation)
- EWS Certificate of the previous Financial Year.

- K. Passport Size Photograph (06)

- 2. Payment of Rs. 35,000/- (Thirty Five Thousand Only) should be made through Chancellor Portal Online and receipt of the same should be furnished at the time of counseling.
- 3. Provisionally selected candidates shall bring all the original documents on the date of counseling. Non furnishing of original documents on the date of counseling shall lead to cancellation of Candidature.
- 4. Merely featuring of name in the provisional selection list does not create "right of selection" in favor of any candidate.
- 5. Admission of any candidate shall only be confirmed after verification of documents and eligibility according to Bar Council of India Regulations on legal education or any other guidelines issued by the competent authority(ies).
- 6. Candidates claiming benefit of reservation must have caste certificate/domicile certificate of Jharkhand state issued by the competent authority in Original Copy.
- 7. Candidates claiming the benefit of EWS criteria must furnish the certificate issued by the competent authority from the concerned official portal only of previous financial year.
- 8. Those candidates who have not been selected in BBA.LL.B Entrance Test 2025 and want to see their Answer Sheets may apply through prescribed format of application with depositing of Rs. 200/- through Demand Draft in favour of "A-1 Institute of Legal Studies". Answer Sheet of applicant will be sent to the e-mail id of applicant within 72 hours.
- 9. After completion of last dated in respective selection list and as notified by the Institute to that effect, the candidature of provisionally selected candidates would automatically be cancelled.

10. Withdrawal of Admission by any candidates shall be governed by the UGC Regulations notified and updated from time to time in that regard.
