# Editorial

*This issue of 'Cannon' is significant in a special way. As we complete 75 glorious years of Indian independence and mark the Azadi ka Amritmahotsav it is time to ponder over the Indian Constitution, a book we all owe allegiance as citizens of the country. On August 15, 1947, the newly appointed Constituent Assembly was given the task of drafting a Constitution for India. The greater part of this onerous responsibility fell upon the shoulders of Dr. BR Ambedkar, the then law minister who was elected chairman of the drafting committee. He and his colleagues made a careful study of the constitutions of various countries, besides considering the common law traditions of Britain and the decisions of the Supreme Court of the United States. The draft was completed in 1949 and adopted by the Parliament in 1950.*

*The Constitution of India guarantees equal rights to all citizens and prohibits discrimination on the basis of race, ethnicity, gender, caste and religion; it also allows universal franchise, thereby making the Indian electorate the largest world. The Fourth Part of the Constitution contains what are called "directive principles of state policy", which require the government to set goals for the welfare of the people.*

*The Indian state, however, has been lax in its commitment to the Constitution for shaping of a truly functional constitutional republic. It was imperative that from the word go, the state had to chart out policies and programs for the enforcement of the "directive principles". Besides, constitutional rights have been abrogated much too often in the past 75 years. The first blow was dealt during the internal Emergency of 1975-77, proclaimed by Prime Minister Indira Gandhi when the constitution was rendered ineffective. Subsequent regimes have emulated this precedent, not on such a grand scale, but definitely aimed at different fundamental principles enshrined in the Constitution, such as federalism, Rule of Law, independence of the judiciary and so on.*

*Review of the Constitution is a necessity but the members of the present day polity are least equipped to carry it out. If the members of the present government were really serious about starting a debate on the subject and initiating a process of long-term change, it would keep aside political considerations and entrust the job to constitutional experts. Also the mandate of the people would have to be gauged. All this requires long-term vision and perspective.*



# News & Judgments

## ***International Legal Updates:***

- US House passes Ro Khanna's historic amendment on sanctions waiver to India

The United States House of Representatives approved Indian-origin Congressman Ro Khanna's amendment to the National Defence Authorization Act (NDAA) on Thursday, paving the way for an India-specific waiver for the CAATSA sanctions. The Countering America's Adversaries Through Sanctions Act (CAATSA) became a sticking point in India-US ties after New Delhi inked a deal to secure the S-400 missile defence system from Moscow, in the midst of the Russia-Ukraine war. Washington had been mulling whether to apply or waive sanctions on India over the deal.

- Inflation hits record 8.9% in euro area, but economy grows

Inflation in the European countries using the euro currency shot up to another record in July, pushed by higher energy prices driven partly by the war in Ukraine. The euro-area economy managed to expand by 0.7% from April through July over the previous quarter, contrasting with the contraction in the United States, where fears are growing of a recession. The outlook is just as gloomy for Europe.

- Ranil Wickremesinghe: Sri Lanka sees new president sworn into office

Sri Lanka's Ranil Wickremesinghe has been sworn in as president, amid hopes that he will pull the country out of its economic suffering. His victory on 20 th July, 2022 Wednesday means he will serve out the rest of the presidential term until November 2024.

- Ukraine ready for first grain ship in Russia deal

The first grain ship from Ukraine since Russia's invasion is ready and waiting for the signal to leave port, says President Volodymyr Zelensky. With hopes of an imminent departure, President Zelensky joined ambassadors from the G7 industrialised nations on the Black Sea coast, standing in front of the Turkish-registered ship Polarnet.

## ***Supreme Court Judgements:***

- Supreme Court Issues Notice In Plea Seeking Constitution Of State Bar Council In Jammu & Kashmir And Ladakh

A Bench comprising Justices D.Y. Chandrachud and J.B. Pardiwala issued notice to the concerned authorities. The petition argued that the entire legal fraternity in Jammu & Kashmir and Ladakh has no Government established body where they can get themselves enrolled. They are also deprived of the benefits that lawyers of the other states get from their respective Bar Councils. The petition has been filed through AOR Om Prakash Parihar.

- Section 306 IPC - Abetment Of Suicide A Heinous Offence ; Cannot Be Quashed On The Basis Of Compromise : Supreme Court

The Supreme Court observed that an FIR under Section 306 IPC (abetment of suicide) cannot be quashed under Section 482 CrPC on the basis of settlement. The bench comprising Justices Indira Banerjee and V. Ramasubramanian observed that 'abetment of suicide' also falls in the category of heinous and serious offences and are to be treated as crime against society and not against the individual alone.

- No Repugnancy With Central Act" : Supreme Court Upholds Sections 4(7),4(8) & 15 Of Kerala Motor Vehicles Taxation Act, 1976

The Supreme Court upheld the constitutional validity of Sections 4(7), 4(8) and 15 of Motor Vehicles Taxation Act, 1976 and Section 8A of the Kerala Motor Transport Workers' Welfare Fund Act, 1985. Dismissing the appeals against the Kerala High Court judgment, the bench of Justices AM Khanwilkar, Abhay S. Oka and CT Ravikumar observed that these provisions are in no way in conflict with the Motor Vehicles Act, 1988. "The State enactments do not create any new liability or obligation in relation to the permit issued under the 1988 Act (Central legislation), but it provides for dispensation to ensure timely collection of the welfare fund contribution as well as vehicle tax payable by the same vehicle owner/permit-holder", the bench observed.

- Nothing Unusual In Mother Giving Surname Of Second Husband To Child After Death Of Biological Father : Supreme Court

The Supreme Court has observed that a mother who remarries after the death of the biological father can decide the surname of the child and include it in her new family. The bench comprising Justices Dinesh Maheshwari and Krishna Murari set aside an Andhra Pradesh High Court judgment which directed a mother to change the surname of her child and also to show the name of her new husband in records only as 'step father'.

- Section 436A CrPC Akin To Statutory Bail ; Can Be Invoked By Accused Arrested Under PMLA : Supreme Court

The Supreme Court observed that the beneficial provision of Section 436A of Criminal Procedure Code could be invoked by the accused arrested for offence punishable under the Prevention of Money Laundering Act, 2002 Act. Section 436A CrPC needs to be construed as a statutory bail provision and akin to Section 167 CrPC, the bench comprising Justices AM Khanwilkar, Dinesh Maheshwari and CT Ravikumar observed in a judgment in which it upheld the the Constitutional validity of "twin conditions" for bail under amended Section 45 PMLA.

- Supreme Court Permits High Courts Which Stopped Hybrid Options To Be Impleaded In Plea Seeking Virtual Hearing As Fundamental right

In a batch of petitions seeking declaration of virtual hearing as a Fundamental Right, the Supreme Court, on Monday, allowed impleadment of High Courts, which have stopped virtual hearing.

- Section 141 NI Act - Not Necessary To Specifically Plead That Managing Director Is In Charge Of The Company's Affairs :  
Supreme Court

The Supreme Court observed that it is not necessary to make an averment that a Managing Director or Joint Managing Directors were in charge of and responsible for the conduct of the business of a company to make them accused under Section 141 of the Negotiable Instruments Act, 1881. The court reiterated that impleading of independent and non-executive directors of a Company on the basis of a statement that they are in charge of and responsible for the conduct of the business of the company, without anything more, does not fulfil the requirements of Section 141 NI Act. The bench comprising Justices Indira Banerjee and JK Maheshwari observed that specific averments have to be made in the pleadings to substantiate the contention in the complaint, that such Director was in charge of and responsible for conduct of the business of the Company or the Company, unless such Director is the designated Managing Director or Joint Managing Director who would obviously be responsible for the company and/or its business and affairs.

### ***High Court Judgements:***

- Transgender Persons Entitled To Participate In Sporting Events In Gender Of Their Choice In Absence Of Separate Category:  
Kerala High Court

The Kerala High Court, on Friday, while passing an interim order in a Writ Petition, observed that in sporting events, in the absence of a separate category for transgender persons, they must be permitted to participate in their chosen category. Justice V G Arun, observed that transgender persons are having equal rights to participate in competitions, and in the absence of a separate category, they should be permitted to participate in their chosen category.

- President Appoints Justice Manindra Mohan Shrivastava As Acting Chief Justice Of Rajasthan High Court

The Central Government has notified the appointment of Justice Manindra Mohan Shrivastava as the Acting Chief Justice of the Rajasthan High Court (as per Article 223 of the Constitution of India) with effect from August 2. Justice MM Shrivastava, the senior-most Judge of the Rajasthan High Court, will be performing the duties of the office of the Chief Justice of the High Court consequent upon the retirement of Shri Justice Shinde Sambhaji Shiwaji, Chief Justice, Rajasthan High Court.

- Writ Of Mandamus Not A Remedy Against Private Wrongs, Court Cannot Interfere With Private Body's Internal Management: Delhi HC

Observing that the writ of mandamus is not a remedy against private wrongs, the Delhi High Court has observed that such a writ's scope is against the private authority which might be performing a public duty limited to the enforcement of such public duty.

Further adding that the Court cannot interfere with the internal management of a private body in a writ of mandamus, a division bench comprising of Chief Justice Satish Chandra Sharma and Justice Subramonium Prasad observed thus: "It is well settled that a writ of mandamus lies only for the purpose of a public or statutory duty. Writs are issued for the performance of public duties. Though Article 226 of the Constitution of India is worded in such a way that a writ of mandamus could be issued even against a private authority but such private authority must be discharging a public function and the right sought to be enforced must be a public duty."

- Daughter will not cease to be member of family merely because she is married: Himachal Pradesh High Court .

The High Court held that if the government's policy of excluding a daughter for assessment of family income is approved, the Court would become a party to perpetuating gender inequality.

- Application Under Section 11 Of The A&C Act Is Maintainable Despite The Pendency Of Reference Before The MSME Council: Jharkhand High Court

The High Court of Jharkhand has held that merely because a reference on the same issue is pending before the MSME Council under Section 18 of the MSMED Act, the same is not a bar to the application under Section 11 of the A&C Act for the appointment of the arbitrator.

Bench of Justice Sujit Narayan Prasad has held that the High Court while exercising powers under Section 11 of the Act is only required to see if there is an arbitration clause between the parties and an objection regarding the pendency of a reference before the MSME Council on the same matter is not to be looked into at that stage.

- Person Not Being A Rly Servant Travelling In A Goods Train Not Entitled To Compensation: Jharkhand High Court

In an important observation, the Jharkhand High Court has said that if a person, not being a railway employee, is traveling in a goods train and falls down from such a train, then he is not entitled to compensation from the Railway administration. The bench of Justice Ananda Sen further clarified that if such a person cannot be treated as a passenger in terms of Section 123(C)(2) of the Indian Railways Act and therefore, he is not entitled to be compensated.

- Appellate Courts Can Allow Additional Evidence U/S 391 CrPC Only In "Exceptional Circumstances": Jharkhand High Court

The Jharkhand High Court has held that Appellate Courts can allow additional evidence under Section 391 of the Code of Criminal Procedure, 1973 ('Cr.P.C.') only in "exceptional circumstances" and the same cannot be used merely to fill in lacuna that might exist in the evidence. While upholding the order of the Lower Appellate Court, a Single Judge Bench of Justice Sanjay Kumar Dwivedi observed, It is settled proposition of law that for filling in lacuna, the petitions under Sections 311 and 391 Cr.P.C. and Section 165 of the Evidence Act are not being allowed. Only in the exceptional circumstance, at the appellate stage, the court can allow the additional evidence in terms of Section 391 Cr.P.C."

I love the subjects I get to study and feel proud of skills that I've incorporated by this time. Every morning when I jump out of my bed, I'm re-energised to learn something new and use it for a social cause. My confidence is on another level when I get to argue and debate in moot courts. It gives me immense pleasure to read cases and solve it.*




